GREATER VALLEY YMCA Membership Agreement & Waiver

1. I hereby authorize the Greater Valley YMCA to initiate debit transactions to my account as indicated below. I authorize that the bank account information submitted is accurate & that faulty information is means for immediate termination of membership privileges.
2. It is to my complete understanding that if I wish to terminate or change my membership in any way, I must give the YMCA a minimum 15 day written notice prior to my assigned withdrawal date.
3. The YMCA Board of Directors may, at their discretion, adjust the monthly rate applicable to my category of membership. I understand that I will receive at least 30 days notice prior to any such change.
4. Should any monthly draft not be honored by my bank for any reason, I realize that I am still responsible for any service fees my bank may assess; I also understand I/my family will be denied access to the facilities until the balance is paid. A \$25 YMCA processing fee will be assessed to the account.
5. I agree that the Y shall not be responsible for any personal injuries or losses sustained by me/my family while on any Y premises, or as a result of any Y sponsored activities. I further agree to indemnify and hold harmless the Y for any claims or demands arising out of any such injuries or losses.
6. I have received information on how to obtain a copy of the Member Handbook, and fully understand all of the policies and terms of the membership. If at any time I fail to follow the guidelines set forth by the YMCA, the YMCA may terminate my membership without any form of refund.
7. I understand that the Y may use my or my family's photos for promotional and marketing materials. I agree to allow pictures, video and audio tapes of myself/family members for promotional and marketing materials for no compensation.
8. The YMCA conducts regular sex offender screenings on all members, participants and guests. If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation and remove visitation access.

GREATER VALLEY YMCA Member Code Of Conduct

As a member of the Greater Valley YMCA, I will refrain from the following:

1. Using offensive language, wearing revealing clothing and exposing inappropriate tattoos. Please wear your swimsuit only in the pool area and locker rooms. Shoes, shorts or pants are required in other areas of the facility.
2. Making physical contact with another person in any angry or threatening way.
3. Engaging in sexual activity or inappropriate contact with another person.
4. Harassing or intimidating by words, gestures, body language, or any other menacing behavior.
5. Stealing or other behavior that results in the loss or destruction of property.
6. Smoking or Vaping. All Y facilities and grounds are smoke-free/vape-free environments.
7. Displaying threatening, inappropriate or offensive conduct.
8. Carrying or concealing any weapon or device or object which can be used as a weapon.
9. Abusing or defacing the Y building or its equipment.
10. Using or possessing illegal drugs or alcohol on Y property or in Y vehicles.
11. Posting unapproved materials. Ask the Member Services Director for permission to post flyers in the Y facility or surrounding properties.
12. Use of camera or cell phones is not allowed in the locker rooms, bathrooms, or aquatics areas.
13. Conducting/participating in paid personal training or other instructional sessions with an instructor not employed by the Y.
